# 3. SCOPE

These Conditions of Participation govern participation in the ORNARIS specialist trade fair and supplement the currently applicable General Terms and Conditions of Participation of BERNEXPO AG. Also applicable are the General Regulations of BERNEXPO AG as well as the General Regulations of MCH Messe Zürich. In the event of contradictions, the provisions in these Conditions of Participation for ORNARIS shall take precedence over those in the General Terms and Conditions of Participation of BERNEXPO AG.

# 4. PURPOSE OF THE SPECIALIST TRADE FAIR

ORNARIS serves as an information and meeting platform for professionals in the consumer goods sector, and is the only national specialist trade fair for retail in Switzerland.

# 5. PERMITTED EXHIBITORS

All business enterprises related to the sector are permitted to exhibit at the trade fair. There is no right to participate. Applications for participation can be rejected without providing reasons.

# 6. TARIFS

The following services will be added to the stand rental in any case, unless they are included in the package price:

- Basic communication package (from CHF 350.00)
- Power socket (from CHF 218.00)
- Electricity supply incl. grid usage (from CHF 43.60)
- Service flat rate (according to table)

All co-exhibitors will be charged a flat-rate service fee (participation in general ancillary costs and waste disposal/recycling) according to the following calculation key:

Stand size up to 25 m <sup>2</sup>	CHF 55
Stand size up to 26 – 50 m²	CHF 65
Stand size up to 51 – 100 m <sup>2</sup>	CHF 96
Stand size up to 101 – 300 m²	CHF 168
Stand size up to 301 m <sup>2</sup>	CHF 252

We reserve the right to adjust the service fee for larger quantities.

# **6.1 DISCOUNTS**

Applicable to:

- Hall booth area without set-up
- Core booth package
- Edge booth package
- Advanced booth package

Multi-fair contract	Price in CHF per m <sup>2</sup>
2 trade fairs	CHF 15
4 trade fairs	CHF 25

### Valid for:

- Stand area hall without stand construction
- Core stand package
- Edge stand package
- Advanced stand package

The discounts can be combined.

# 7. CANCELLATION OF REGISTRATION

# 7.1 By exhibitor or co-exhibitor

In the event of cancellation of the registration (online registration or after **receipt of the confirmation of receipt**), the following cancellation costs apply:

Item description	Flat fee
Cancellation fee – up to 30 m <sup>2</sup>	CHF 500
Cancellation fee – 31–70 m <sup>2</sup>	CHF 1,000
Cancellation fee – 71–110 m <sup>2</sup>	CHF 1,500
Cancellation fee – from 111 m <sup>2</sup>	CHF 2,000

In the event of cancellation of the registration **after receipt of the stand confirmation**, the rates according to point 3 of <u>the General Conditions of Participation</u> of BERNEXPO AG apply. If a co-exhibitor cancels its participation, the full co-exhibitor surcharge and the supplementary costs will still be payable.

# 8. CO-EXHIBITOR FEE

Co-exhibitor as defined by the applicable General Terms and Conditions of Participation. Payment of the co-exhibitor fee entitles co-exhibitors to the following rights:

- · Company address on the main exhibitor's booth
- · Sales activity at the main exhibitor's booth
- Entry in the list of exhibitors
- Entitlement to order guest tickets
- Entitlement to advertising materials for exhibitors

# 9. CANDLES

Lighting candles is generally prohibited. Exceptions require approval and must be submitted for ORNARIS Bern 2026 by mid-July 2026 using the form "Application for Permission to Light Candles."

Goods deliveries to the halls during the trade fair are only possible until 9 a.m.
